# Financial Update (Mike)

- Summary shared by Mike

  - We'll standardize our financial reporting to comply with 501(c)3 requirements
- Club has \$26,677 in net assets (minus liabilities)
- Good position heading into 2025 BTC
- Dennis Condos suggested we do more outreach and support
- Chloe Stein noted we should make a better effort to make this accessible to members.

### **Course Updates**

- Wildflower garden was a big success! Teia to plan 1 or more additional for installation this winter...?
  - Teia confirmed intent
  - Update: Teia led the reseeding of the existing garden in the fall!
- Significant rain the past 2 winters led to a LOT of vegetation growth and required a LOT of time to manage.
- Equipment: Purchased new equipment to make management more efficient
  - o (2) NEW walk behind string trimmers (like a mower but with string)
  - o (1) NEW hand-held string trimmer w/harness & handlebars
    - (2) owned
  - o (1) Existing good mower
  - o (2) Existing good hand-held string trimmers
  - Now have (7) machines (up from 4)
- Tee signs: Some are starting to peel; have been in contact with the vendor; they will replace 5 of the worst ones to determine whether it's a bad batch of material; they've had signs outdoors for 7+ years with no issues.
- Pyramid: Was demolished due to safety concerns; Bryan S. is leading the rebuild project; hopefully will be completed by BTC
- Additional Safety nets are needed on various holes
  - Hole 2, 8 extension, 9 (?), 12, 15
  - Can someone team up with SJ to get this started?
    - Need to custom order nets
    - Kevin Smeds to partner to get the order done
    - Goal to complete before BTC
- Tree Protection: Partial success
  - Bob M and Shawn installed tree protection on Hole 5 and 8
  - Design needs improvement (winter project?)
    - Round posts / stakes may be better; eliminates stress concentration when discs hit corners of wood with 90
  - Seems like Hole 5 is a great testing ground
- New Trees: Jabir would like to plant several new trees
  - o [Redwood] Behind 3's tee (no structures required)
  - o [Cypress] Right side of 8, before tea tree bushes (structure required)
    - Reviewed the structure location with Leonard on 11/16
    - Structure will protect tree and help bushes recover
  - [Live Oaks] Left side of walking path between 11 & 12 tees
  - [Cypress] Behind dead bush on 14 (structure required)
    - Needs to review with Leonard
  - [Cypress] Near 16 teepad
- 5.5 Tee: Closed due to over-use during dry season

- Needs to be fixed and repacked
- If we don't want to rebuild it every year, this tee should be used sparingly after Safari.
- Short Tees: Could alleviate backups on heavy traffic days
  - Most helpful on 3 & 12 (possibly 5)
  - Worked great for MMM but cannot be "permanent" unless we do some type of hard-scape.
- CLUB VOTE: Add optional drop zone on Hole 3
  - o If drive goes OB, option to proceed to drop zone
  - o Andy Rothschild proposed a permanent drop zone on hole 3
  - Vote results: Motion Passes
    - 23 yay
    - 3 nay

# **Bylaws Feedback**

- Bylaws published on website and feedback form sent out 08/29 (FB) & 09/03 (email)
- Form was open for over a month
- 8 responses
  - (Responses 1,2,4) with no bylaws notes (e.g. "Nice work")
  - (Response 3) advising updates to strengthen language in section 7.06
     Indemnification as well as urging board to secure D&O insurance

- Changes implemented to indicate the corporation *will* forward funds in the event of a lawsuit against BOD member(s) due to role in corporation
- D&O insurance will be acquired by BOD
- (Response 7) asking about Conflict of Interest "guard rails" for BOD. Some concerns about BOD self-dealing / drawing income from the corporation.
  - Created Conflict of Interest Policy and COI Acknowledgement & Disclosure form. All members of BOD must disclose potential conflicts and sign the disclosure form each year (per the policy).
  - Documents are posted on the website and required of corporation filing for 501(c)3 tax exempt status
- (Responses 5,6) Concerns that club members will not elect board members / officers of the board.
  - In the past, club members became officers by being engaged in the club and its mission. Participating in work parties, running tournaments, attending meetings, and taking on duties for the club are the best ways to get engaged and eventually take on a leadership role. Elections were held at meetings of which 10% or less of the club typically attend. We are not aware of anyone being voted down if they had demonstrated competence and willingness to take on duties on behalf of the club. In our view, the vetting process for prospective leaders / board members will not change. The current BOD / Officers will absolutely be looking for others to hand off duties to, including joining the board and becoming an officer of the board.
  - We were advised early in this process to keep the structure as simple as possible and to minimize overhead required to manage the legal entity. This will help ensure we can meet our legal obligations while spending the majority of time furthering our mission. Requiring yearly elections would greatly increase overhead and potentially put the entity at risk.
  - What holds BOD accountable?
    - Laws governing corporations, specifically public benefit / non-profit corporations
    - Transparency of: Bylaws, COI, tax filings, etc
    - Revenue: Membership dues are the primary source of income; if people do not become members, the corporation will not have funds to fulfill its mission.
- o (Response 8a,8b)
  - a) What benefits / duties do club members have?
    - Need to draft / adopt a membership benefits / duties policy;
      - Example Benefits: bag tag(s), participation in meetings, discount on club merch, other discounts (e.g. PDGA); would like to add discounts to local businesses!

- Example Duties: Be a good steward of the course, be a good representative of the SFDGC in every interaction with non-club members (disc golfers or not)
- b) What obligations does the club have to the city and how is this documented?
  - The SFDGC signed an MOU with the city of San Francisco in late 2006
  - Club responsible for all costs and labor associated with construction and upkeep of "improvements"
  - Club allowed (3) permitted events per calendar year
    - Recently expanded to (4) after several years of "lobbying"
